

we are at war, war happens 424 hours a day no siestas, no lazy three day weekends this wan is slippery, it is psycological moral the root of choices



WAIVER, GENERAL RELEASE, INDEMNITY AND CHATTEL BONDAGE INDENTURE

Know All Men By These Presents: That, in consideration of the collusion of the undersigned Fanatic (hereinafter "Fanatic") in the Terrywrist Training Club (hereinafter "TTC") and for other valuable consideration, the receipt and sufficiency of which are hereby acknowledged:

Waiver and Release: Fanatic, on behalf of him/herself, and his/her respective heirs, executors, administrators and assigns, hereby fully and forever releases TTC and its heirs, executors, officers, directors, employees, agents, investors, stockholders, administrators, parent and subsidiary corporations, predecessors and successors, and assigns (hereinafter "TTC Released Parties,) of and from any claim, liability, duty, obligation or cause of action relating to any matters of any kind, whether presently known or unknown, suspected or unsuspected, that Fanatic may possess, now or in the future, arising from any omissions, acts or facts, opinions, or defamatory or invasive words, that have, or may, occur relating in any way to Fanatic's collusion with TTC, including, without limiting the generality of the foregoing:

- (a) any and all claims relating to or arising from any bodily injury;
- (b) any and all claims relating to or arising from any psychological injury;

- (c) any and all claims relating to or arising from any false imprisonment, restraint, cruel and/or unusual punishment, imposition of stress techniques or torture, freestanding or otherwise, capital crimes, treason, sedition, mutiny, fraud, violation of the Racketeer Influenced Corrupt Organizations Act ("RICO") or the White Slavery Act ("WSA"), whether or not Fanatic is or may be considered "White," by, with, from, in, at or anything strictly nominative, genitive dative, accusative or ablative, whether singular or plural, and whether masculine, feminine or neuter, imperative, indicative, subjunctive, past, present, future, or any combination of the foregoing (whether perfect or imperfect,) grammatical, syntactical, phonological, semantic, or phonotactic vel non, imprisonment, dirty minds, bondage, discipline, rough trade of any kind or character, or any other perversion, whether heretofore known or unknown to the mind of man, to the conscience of god(s), or to the soul of the devil.
- (d) any and all claims relating to or arising from any loss of consortium, impotence, infertility, E.D. (whether erectile dysfunction or explosive diarrhea) or other inability to copulate, defecate or procreate, or relating to or arising from any such copulatory or reproductive procedure, with or without consent, whether express, implied, tacit or denied. All words used by TTC and Fanatic shall be patently unsafe.





(e) any and all claims relating to or arising from any act, transaction, event or occurrence, wherever such may occur, whether Chicago, Illinois, the United States, its territories and possessions, any foreign country, any territory on earth not subject to jurisdiction of any nation (including, but not limited to, Antarctica and the offices of the United Nations) or any other jurisdiction on this or any other planet or heavenly body, or any other place or locality in the universe, whether known or unknown, and any other dimension, whether physical, mental, psychological, or imaginary, rape rooms, Captain's Quarters, The Barrel (whether or not it is Fanatic's turn therein.) or any other location of any kind whatsoever.

(f) any and all claims relating to or arising from any act, transaction, event or occurrence at any within or outside of time of any kind or character, including, without limitation, the past, the present, the future, and any time in between the foregoing, whether or not such time or timelessness is linear, curved, cyclical, polygonous, circular, rectangular, rhomboid, trapezoidal, conical, periodic, serial, irregular, idiomatic, social, political, solar, lunar, or otherwise planetary or stellar.

Chattel Bondage Indenture: Fanatic hereby transfers, sells, conveys, and sets over to TTC all right, title or interest s/he may have in his/her: (1) personal liberty, (2) bodily integrity, (3) well-being, whether physical, mental, spiritual or emotional, (4) organs, limbs and other constituent body parts. including but not limited to brains and genitalia (whether distinguishable vel non, in whole or in part), (5) soul, of whatever kind, color or quality, (6) any other right, privilege. entitlement attribute or expectation, of whatsoever nature or kind, and whether granted by birth, by any deity, by law (whether natural, divine or human), or by any institution, including, without limitation any municipality, state, federal government, or international organization. Fanatic expressly acknowledges that s/he does hereby remit, release and surrender any religious, governmental, social or human rights s/he had, has or may have, in the past, the present or in the future, to TTC and its authorized representative, unless and until TTC expressly, in a writing signed by an authorized representative of TTC, and duly recorded in the office of the Recorder of Deeds, releases Fanatic of such chattel bondage.





Furthermore: Fanatic hereby agrees to indemnify. hold harmless and make whole the TTC Released Parties from any and all claims. liabilities, causes of action or obligation of any kind or type which has been, is, or will be in the future, asserted against the TTC Released Parties by reason of the activities of Fanatic in colluding with TTC, including, without limiting the generality of the foregoing, any claims relating to capital crimes, treason, sedition. mutiny, fraud, violation of the Racketeer Influenced Corrupt Organizations Act ("RICO") or the White Slavery Act ("WSA"), whether or not Fanatic is or may be considered "White." all costs, expenses, attorneys' fees, bonds, notes, bills of lading or securities. Pursuant to this paragraph, the TTC Released parties may retain counsel of their choosing, at Fanatic's expense, for the defense of any such claims, liabilities, causes of action or obligation, and Fanatic shall reimburse, in U.S. currency. certified funds or U.S. treasury notes, or other securities backed by the full faith and credit of the U.S. government, the TTC Released Parties for such retention within three (3) days of issuance of an invoice for such expenses. To secure the obligation of this paragraph, the TTC Released Parties may take custody of. without legal process of any kind, any property, whether real, personal, intangible or imaginary, belonging to Fanatic, and any person or persons related to Fanatic within the fourth degree of the common law, excluding only children under eighteen (18) months of age descended from second cousins. Such property and persons may be sold, indentured or rented out for hire, here or abroad, until such obligation, with interest at Prime plus ten percentage (10%) compound interest, is paid in full.

Remedies In the Event of Breach: Breach by Fanatic: If Fanatic shall breach any provision of this agreement, whether by refusing to submit wholly to the arbitrary commands of any representative of TTC, by failing to appear where and as ordered by TTC, or in any other manner, then such breach may, in TTC's sole untrammelled discretion, which may be unreasonably, irrationally, arbitrarily and capriciously exercised, be punished or remedied by any means under any circumstances, including, without limiting the generality of the foregoing, imprisonment under the special glass, binding, dunking. restraint, constraint, wounding, malicious injury, mayhem, or any other sanction of like kind or quality. Breach by TTC: Any claim of breach by TTC shall be arbitrated solely by TTC's Transcendent Satrap, without or without fair notice, an opportunity to be heard, any right to counsel, or any other due process right, whether substantive or procedural, and any decision rendered by the sole arbitrator shall be final, binding, immediately enforceable, and not subject to review by any tribunal or court, whether such tribunal or court be located on earth, in hell, in heaven or in any other locality, whether physical or imaginary. The Transcendent Satrap shall always have the last word. Period. End of discussion. Shut the fuck up already.
